## Community Bulletin – Winter 2024

Essential, necessary upgrades to the campus hydrant and fire sprinkler systems under CDC approval have been hampered by rain, which, in turn, have delayed completion of Roseville College's Sport and Wellbeing Centre, a State Significant Development (SSD - 9912).

In this bulletin, we explain the delay and share progress photos of the project during the final construction stage: services and fit out. We also share news about the Learning Partnership of Roseville College and Taylor to promote careers for women in construction.

### Update on CDC Works

# Progress of SSD-9912 is delayed by the associated CDC works, which were hindered by rain.

CDC work is necessary for campus hydrant and fire sprinkler systems, and to alleviate demand on shared street water mains. This requires installing new underground sprinkler and water storage tanks (where the old pool used to be) and replacing the main pathway into the school from Bancroft Avenue.

Fortunately, blue skies in July allowed sufficient time to pump out pooled water, complete detailed excavation and pour the concrete footings. Revised completion dates are published under 'Project details' at the project website. **W**

#### **Upcoming Works**

- Level 1 Amenities toilet partitions
- Wall framing, sarking, and insulation
- Installation of handrails and balustrade to Stair 4 and Stair 8
- Lighting connection in Level 1 2 car park
- Installation of glazing (Stair 1)
- Installation of plywood ceiling, acoufelt and Carpet (Level 2)
- Framing to install windows on Level 2 gym
- Waterproofing on Level 3 sports court
- Detailed excavation of Stair 8
- Waterproofing to upturn walls and sheeting of walls in Pool hall, and tiling
- Epoxy flooring to Pool concourse
- Installation of Level 3 sunshade, flooring to Level 3 rooms and operable walls.

#### **In Progress Works**

- Services roughed in to Level 2 and Level 3
- Fitting off Level 1 amenities
- Tiling of the pool floor and structure
- Install joinery for Level 2 and Level 3
- Painting on Level 2 and Level 3
- · Closing ceilings on all levels
- Formwork, reinforcement and concrete pour of hydrant tank and detention tanks.

#### **Completed Works**

- Scaffold in Pool Hall to install skylights
- Brickwork to south- and s/eastern facade
- Concrete pour to remaining concourse
- Epoxy flooring to pool and amenities.


Associated CDC Works | Work per Complying Development Certificate (CDC-GDL230398) is underway using the same access gate in Bancroft Avenue as the SSDA work. Note: On Saturdays, CDC approved work hours are 7am - 5pm, unlike SSDA hours of 7am - 1pm.

# Although rain has delayed CDC works and progress on the court surface, significant work continues.

Completion is expected in Term 4, with end-dates revisited periodically and published under 'Project details' at the website (see back page). Despite rain hampering the critical path of some aspects, there is significant progress around and within the Centre. This includes finishing to the facade and interior, such as installation of electrical and communication services; finishing of windows and skylights; readying planter boxes for landscaping; installing ceilings, flooring and bay windows in classrooms; tiling for the pool and amenities, floor and stair surfacing, installing joinery, and progressing signage for wayfinding. **W**

#### Women in construction

Since 2022, Taylor employees have participated in several events to inspire Roseville College girls about careers in the construction industry.

At the end of Term 2, Year 10-12 students attended a breakfast with four women leaders from Taylor, who shared career stories and pathways, outlined their daily responsibilities, and described the challenge of balancing study and a cadetship in the industry. (Cadetships expose undergraduates to construction projects and work sites, enabling them to start their career while still gaining their qualifications.)

Such events help students appreciate that transferable skills and continuous learning are important for navigating the ever-changing demands of the workforce. Many of our students will experience a non-linear career across several different industries and job functions in their lifetime. W
