## Key responsibilities

#### Head Swimming program development and coaching

- Overall responsibility for designing and implementation of the Roseville College swimming program.
- Design and implement IGSSA and IPSHA competitive swim squads training programs.
- Attending all competition meets with the squads.
- Deliver technically appropriate sessions that run on time and involve all participants enrolled in the program.
- Facilitating the skill development of swimmers with a range of skill levels to achieve performance outcomes.
- Recording training data to analyse strokes, techniques, and monitor progress.
- Setting training goals and objectives and motivating teams as well as individual swimmers.
- Lead, train, and mentor swimming coaches to provide exceptional service to the Swim program.
- Identify and resolve complaints and situations using a range of problem-solving and decision-making tools. Resolve in a manner that promotes positive customer service.
- Deliver service excellence to parents and carers by proactively engaging with and responding promptly and courteously to enquiries and requests for information.
- Keep abreast of changing rules, techniques, technologies, and philosophies relevant to swimming.
- Monitor and ensure safe and proper use of swimming equipment.
- Collaborate to set clear performance standards and deadlines in line with established performance development framework.
- Enact safety and risk management processes including ensuring that pool and training area is free of hazards and that supervision of all pool-based activities is maintained

#### **Pool Operations**

- Respond to emergencies in accordance with your training.
- Perform water rescues where required, in accordance with your lifeguard training and be prepared to enter the water at any time if required.
- Timely completion of all Aquatic Centre daily operations task checklists, inspections and facility walkthroughs.
- Respond to and manage first aid and other incidents within the centre and complete the relevant incident report forms in a timely manner.
- Act as an Area Warden during an evacuation and attend regular evacuation training exercises.
- Ensure the provision of a safe, professional, functional, well presented and clean aquatic environment, implementing standard operating procedures where applicable.
- Ensure the facility is set up for aquatic based programs or bookings in accordance with the daily booking schedule.
- Implement operational systems and procedures and allocate resources to ensure operational requirements are met and maintain high standards of service delivery, venue presentation, safety and security.
- Supervise the safe use of the facilities and promptly identify and action potential issues which may cause injury or illness to staff
  or patrons.
- Ensure the prompt reporting and action of maintenance and cleaning issues and escalate where required.
- Liaison with key pool and aquatic plant contractors as required.
- Work closely with the Facilities team and the Sports/PDHPE team.
